Vice Presidential Officers' Assignments for 2025-2026

As required by the Constitution of the VSFA:

ARTICLE 3 - DUTIES OF OFFICERS AND EXECUTIVE COMMITTEES

Section 4. It shall be the duty of the Vice President, in the order elected, to occupy the place and perform the functions of the President in his absence. They shall act under the direction of the President and in the event of the resignation, death or disability of the President, the duties of that office shall devolve upon the first Vice President. In the absence of the President and the three (3) Vice Presidents, a President and Vice President shall be elected *pro tem* by balloting by the Chairman of the Companies or Departments present.
